- 2. Grow the Manned Guarding division to achieve a £2 million turnover by the end of 2027.
- 3. Provide SIA and stewarding services to major music and sporting venues currently achieved with Utilita Arena, Aston Villa FC, and Cambridge United FC contracts.
- 4. Expand our client portfolio across London and other major UK cities.
- 5. Continue to grow our Highfield-approved training provision, delivering in-house and external courses.
- 6. Add new Highfield-accredited training courses including Door Supervisor, Door Supervisor Upskill, and Safeguarding.
- 7. Invest in staff development and progression, supporting continuous learning and professional accreditation.
- 8. Continue building a culture of excellence, ensuring quality, reliability, and pride in everything we do.

- ACS Accreditation: Successfully achieved in 2023 for both SIA Door Supervision and Manned Guarding, enhancing our credibility and competitive edge.
- Client Retention: Maintained strong relationships while securing new clients through proactive engagement and reputation-based referrals.
- Business Growth: Transitioned a former event site into a manned guarding contract and secured new high-profile event partnerships including Truckfest and the Antiques Fair.
- Sports & Major Venues: Expanded into the sports sector, providing SIA-licensed staff to Aston Villa FC, Cambridge United FC, and the Utilita Arena demonstrating capability across large-scale, high-profile environments.
- Training Expansion: Achieved Highfield registration and launched First Aid training courses, with plans to add Door Supervisor and Safeguarding training in 2026–2027.

TRAINING, SIA UPDATES & PROFESSIONAL DEVELOPMENT

We continue working towards full approval to deliver SIA Door Supervisor Courses at our head office.

SIA Rule Changes 2025:

- From 1 April 2025, licence renewals will require a refresher qualification.
- A valid Emergency First Aid at Work (EFAW) certificate will be required before refresher training
- From 1 December 2025, new 'fit and proper' criteria will apply to licence assessments.
